Chapter-II- General Terms and Conditions of Contract

Subject: Notice Inviting Public Tender for Knapsack Bags (Quantity – 900 Nos.) at HBCSE - TIFR, Mumbai

- 1 HBCSE-TIFR, Mumbai intends to Purchase Knapsack Bags (Quantity – 900 Nos.)
- 2 The bids should reach this office on or before **25-03-2025 up to 14.30 hrs** duly sealed superscribed with

3 **Parties:**

The parties to the contract are the contractor (the Bidders to whom the Purchase Order will be awarded) and the HBCSE-TIFR through Head Administrative Operations, Homi Bhabha Centre for Science Education, Mumbai for and on behalf of the Centre Director, HBCSE-TIFR, Mumbai.

4 **Address:**

4.1 **The Firm should have registered/ functional /branch office in The Mumbai Metropolitan Region (MMR), Maharashtra only.**

4.2 For all purposes of the contract including arbitration thereunder the address of the contractor mentioned in the tender shall be final unless the contractor notifies a change of address by a separate letter, sent by Courier/ Speed Post/ Registered post with acknowledgement to this Centre. The bidder shall be solely responsible for the consequences of any omission or error to notify in change of address in the aforesaid manner.

5 **Earnest Money Deposit:**

5.1 An earnest money for **Rs. 19800/- i.e. 2%** of the total estimated cost has to be deposited in the form of Demand Draft, Bankers cheque or through online transfer through bank in favour of '**Homi Bhabha Centre for Science Education, Mumbai**' and sent along with the Technical Bid. After online transfer of earnest money, the vendor should intimate us by email or proof of online transfer of EMD should be part of tender.

5.2 EMD shall be interest free and it will be refunded to the unsuccessful bidders within 15 days after acceptance of the Contract by the successful bidder without any interest. EMD of the successful bidder shall be returned/ refunded on receipt of Performance Guarantee. However, in case Performance Guarantee is in the form of Bank Guarantee, EMD will be released subsequent to confirmation of verification of Bank Guarantee from the issuing Bank.

5.3 The bidder shall submit the bank details along with the tender like Cancelled Cheque/ NEFT/ Bank A/C details for ease in repayment of EMD.

5.4 If any bidder withdraws the bid before the tender period or issue of Letter of Acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department, then the HBCSE shall, without prejudice to any other right or remedy, be at liberty to forfeit the earnest money without any notice to the bidder.

6 **Bid Security Declaration:**

6.1 The firms registered under MSMEs are exempted from submission of EMD as per rule 170 of GFR 2017, provided they must submit a '**Bid Securing Declaration**'. The declaration should be submitted on the company letterhead duly signed by the officer authorized to submit the bid.

- 6.2 If the bidder withdraws amends/ impairs or derogates their bid during the period of bid validity, Centre reserves the right to suspend the vendor from participating in any tender for a period of three years.
- 7 **Performance Guarantee:**
- 7.1 Successful Bidder (s) will be required to submit a **Performance Guarantee at 5%** of the value of the purchase order at the time of acceptance of award of contract in favour of 'HOMI BHABHA CENTRE FOR SCIENCE EDUCATION', Mumbai within 7 days of acceptance of purchase order. The Performance Guarantee will be valid for a period of **Two Months** beyond the date of completion of all contractual obligation of the Contractor including warranty obligations.
- 7.2 In case Performance Guarantee is not submitted within 7 days, an interest @ 12% per annum will be levied till the date you submit the Performance Guarantee. If the successful bidder fails to submit the Performance Guarantee/ Performance Bank Guarantee with interest or refuses to submit the Performance Guarantee even after reminders, the Centre reserves the right to cancel the order without notice and the EMD by the bidder shall be forfeited automatically. Also, the bidder will be debarred from participating in any tender for three years.
- 8 **Liquidated Damages:**
- 8.1 The date of delivery of the goods, stipulated in the acceptance of the tender should be deemed to be the essence of the contract and delivery must be completed no later than the dates specified therein. Extension will not be given except in exceptional circumstances. Should, however, deliveries be made after the expiry of contracted delivery period, without prior concurrence of the purchaser and be accepted by the consignee, such delivery will not deprive the purchaser of this right to recover liquidated damages.
- 8.2 Should the Contractor fail to deliver the goods or any consignment thereof within the period prescribed for delivery, the purchaser shall be entitled to recover **5 %** of the value of delayed supply for a period up to 4 (four) weeks and thereafter at the rate of **10 %** of the value of the delayed supply for another 4 (four) weeks of delay. Quantum of liquidated damages assessed and levied by the Centre shall be final and not challengeable by the vendor.
- 9 **Micro and Small Enterprises (MSEs):**
- 9.1 As per the Public Procurement Policy (PPP) for Micro and Small Enterprises (MSEs) Order, 2012 issued vide Gazette Notification dated 23.03.2012 by Ministry of Micro, Small and Medium Enterprises of Govt. of India, in order to avail the EMD exemption, the MSEs, must have valid **UDYAM** registration as on due date for submission of a bid.
- 9.2 The MSEs who have applied for registration or renewal of registration with any of the agencies/bodies, but have not obtained the valid certificate as on close date of the tender, are not eligible for exemption/ preference.
- 10 **Preparation and Submission of Tender:**
- 10.1 The tender should be submitted in two parts i.e., Technical Bid and Financial Bid.
- 10.2 The Technical Bid and the Financial Bid should be sealed by the bidder in two separate covers "**Technical Bid for Purchase of Knapsack Bags (Quantity – 900 Nos.) at HBCSE**" and "**Financial Bid for Purchase of Knapsack Bags (Quantity – 900 Nos.) at HBCSE**". Both Sealed Envelopes should be kept in a main/ bigger envelope super scribed as '**Tender Notice No. – HBC/PUR/PUBLIC TENDER/25/2024-2025 'Knapsack Bags (Quantity – 900 Nos.) at HBCSE**'.
a) **Technical Bid:** The Bidders should submit the technical details in **Annexure I** of the contract form.
b) **Financial Bid:** The rate quoted will be exclusive of taxes and shall be fixed and final. Tax Rates, as applicable to be quoted in the bid. It should be submitted in the form given in **Annexure IV**.

- 11 **Quoted rates to include all taxes (except GST):**
Sales tax, VAT, Purchase tax or any other tax on materials in respect of this contract, including state Sales tax and Turnover tax on transfer of property as per Works Contract Act etc. if any (except GST at applicable rate), shall be payable by the contractor and the Centre will not entertain any claim whatsoever in respect of the same. As per the directives of the Sales Tax Authorities, the tax due at the rates notified by the State/ Centre Government from time to time, shall be deducted from the bills payable to the Contractors, for which TDS certificate shall be issued by the Department
- 12 **Communication of Acceptance / Right of Acceptance:**
The bidder should have categorically confirmed acceptance of all the Tender terms and conditions including the payment/ penalty terms. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done. No enquiries, verbal or written, shall be entertained in respect of acceptance or rejection of the tender. On non-compliance/ conformity with the above, the offer is liable for rejection.
- 13 **Clarifications/Addendum/Corrigendum**
- 13.1 At any time prior to the deadline for submission of bids, the HBCSE-TIFR, Mumbai may, for any reason, whether on its own initiative or in response to the clarification request by a prospective bidder, add or withdraw any of the terms and conditions contained in the tender document.
- 13.2 In order to give prospective bidders time to take into consideration the amendments while preparing their bids; HBCSE-TIFR Mumbai may extend the deadline for the submission of bid.
- 13.3 Any addition or amendment in the bidding document, at any time prior to the deadline for the submission of bids, shall be uploaded as “Addendum” or “Corrigendum” respectively on the HBCSE website www.hbcse.tifr.res.in and CPPP <https://eprocure.gov.in/epublish/app> such additions/ modifications shall be binding on all the prospective bidders.
- 14 **Opening of Technical Bid & Financial Bid:**
- 14.1 The sealed quotations (technical bids) will be opened on **25-03-2025 at 15.30 hrs.** at HBCSE-TIFR, Mumbai.
- 14.2 After scrutiny of technical bids, the HBCSE-TIFR, Mumbai shall shortlist the eligible bidders and inform them, the date and time of opening of the Financial Bids. Eligible bidders could participate in the financial opening physically.
- 14.3 In case the date opening of tender is declared a holiday for unexpected reasons, the tender shall be opened at the same time on the next working day.
- 15 **Validity of the bids:**
The bids shall be valid for a period of **6 Months** from the date of opening of the tender. This has to be specified by the Bidders in the commercial bid. A bid for a shorter period of validity shall stand rejected.
- 16 **Delivery Period: 30 Days** from the date of issue of the Purchase order.
- 17 **Signing of contract:**
The Notice Inviting Tender shall form a part of the contract document. The successful Bidders/ contractor, on acceptance of his/ her tender by the Accepting Authority, shall, within 07 days from the stipulated date of start of the work, sign the contract consisting of: The Notice Inviting Tender, all the documents including all conditions, specifications if any, forms the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.

- 18 **Canvassing:**
Canvassing either directly or indirectly, in connection with the tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection and may be barred from the future participation in HBCSE- TIFR works.
- 19 **Non-transferability:**
This tender is non-transferable. Incomplete and conditional Tenders will be summarily rejected.
- 20 **Non-withdrawal of bids:**
No bidders will be allowed to withdraw after submission of bids/ opening of the tender; otherwise, the EMD submitted by the firm will be forfeited.
- 21 **Subletting of contract:**
The firm shall not assign or sublet the contract/ job or any part of it to any other person or party without having first obtained permission in writing from HBCSE-TIFR, Mumbai, which will be at liberty to refuse if thinks fit. The tender is not transferable. Only one tender shall be submitted by one Bidder
- 22 **Purchase Rights:**
- 22.1 The HBCSE-TIFR, Mumbai reserves the right to accept or reject any or all tenders/ quotations without assigning any reason there of and also does not bind itself to accept the lowest quotation or any tender. Any failure on the part of the contractor to observe the prescribed procedure and any attempt to canvass for the work will prejudice the contractor's quotation or any tender.
- 22.2 HBCSE-TIFR, Mumbai reserves the right to relax/ withdraw any of the terms of and conditions mentioned in the Tender Document so as to overcome any problem encountered during the selection of the bidders and also during the course of the execution of the contract.
- 22.3 HBCSE-TIFR, Mumbai reserves the right to blacklist a bidder for a suitable period in case the firm fails to honour its bids without sufficient grounds.
- 22.4 It shall in no way be binding on the Centre to purchase the exact number of quantities as indicated in the tender Document. The actual quantities that may be purchased by the Centre may vary.
- 23 **The Payment clause:**
- 23.1 The payment by the Center will be made within 10-15 working days of receipt of the supply. Any other statutory levy imposed by the Govt. of India from time to time will be authorized extra on demand with adequate proof thereof will be paid extra.
- 23.2 All cost related to packing transportation etc. will be borne by the Contractor. No extra payment will be made by the Centre for whatever purpose.
- 23.3 The Contractor will be solely responsible for paying all applicable taxes as per the rule. In case any penalty/ tax is payable on a later stage, the Contractor shall be liable to pay the same along with the penalty. **Advance payment will not be made by the Centre under any circumstances.**
- 24 **Breach of Terms and Conditions:**
In case of breach of any terms and conditions as mentioned above, the Competent Authority will have the right to cancel the contract/ job without assigning any reason thereof and nothing will be payable by the Centre. In that event the performance guarantee shall also stand forfeited.
- 25 **Legal Jurisdiction:**
The Court of Mumbai in the State of Maharashtra only will have the jurisdiction to deal with and decide any legal matters or disputes what-so-ever arising out of this tender.

26 **Settlement of Disputes/ Arbitration:**

26.1 The Centre and the contractor shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract.

26.2 If, after twenty-one (21) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either Centre or the contractor may give notice to the other party of its intention to commence arbitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commenced unless such notice is given. Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this clause shall be finally settled by arbitration.

26.3 Any liability arising out of any litigation (including those in consumer courts) due to any act of Contractor's personnel shall be directly borne by the Contractor including all expenses, fines, legal costs, penalties etc. The concerned Contractor's personnel shall attend the court as and when required. The Contractor shall ensure that substitute is provided at such times.

27 **Force Majeure:**

27.1 If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of a public enemy, civil commotion, sabotage, fire, floods, explosion, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by the party to other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance, and deliveries have been so resumed or not shall be final and conclusive.

27.2 Further, if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, either party may, at least option to terminate the contract.

28 **Corrupt or Fraudulent Practices:**

28.1 It is expected that the bidders who wish to bid for this tender have the highest standards of ethics.

28.2 HBCSE-TIFR, Mumbai shall reject the bid, declare a bidder ineligible, either indefinitely or for a stated duration, if it at any time determines that the bidder has engaged in corrupt and fraudulent practices during the execution of the order.

Chapter -III Technical Parameters and Specifications

2. Proof of the turnover of **Rs. 9,90,000/-** (Rs. Nine Lakh Ninety Thousand only) for the last three consecutive years.
3. Minimum of **3 (three) years of work experience** in supply of Knapsack Bags (related to the items quoted in the tender) to the Government/ Corporate/ PSU/reputed organizations in India.
4. Experience of having successfully completed the following Purchase Order (during last Three years ending 31 March,2024):
 - I. **One** similar Purchase Order completed costing not less than **Rs.7,92,000/-**; Or
 - II. **Two** similar Purchase Order completed costing not less than **Rs5,94,000/-** each; Or
 - III. **Three** similar Purchase Order completed costing not less than **Rs3,96,000/-** each
5. Each page of the Notice to be signed and stamped by the bidder in token of having accepted the same.

Instructions to bidders

- 1 The job will be entrusted on the basis of an all-inclusive contract on as is where is and competitive rates basis.
- 2 **The rate quoted will be exclusive of Taxes and shall be fixed and final. Tax Rates, as applicable to be quoted in the bid.**
- 3 The rate quoted should be written in ink or typed against each item and should not be overwritten.
- 4 The Bidders must quote rates including freight, insurance, cartage, labour charges etc. on Door Delivery basis at HBCSE-TIFR, Mumbai.
- 5 No Bidder shall be allowed at any time on any ground whatsoever to claim revision of or modification in the rates quoted by him. Clerical error, typographical error etc. committed by the Bidders in the tender forms will not be considered after opening of the tenders. Conditions such as "SUBJECT TO AVAILABILITY, SUPPLY WILL BE MADE AS AND WHEN SUPPLIES ARE RECEIVED" etc. will not be considered under any circumstances and the tenders of those who have given such conditions shall be treated as incomplete and for that reason, shall be summarily rejected.
- 6 **Bidders/ manufacturing unit which has been blacklisted/ debarred for any item either by the Tender inviting authority or by any state Govt. or central Govt. Organization cannot participate in the Tender for that item during the period of blacklisting/ debarment.**
- 7 After due evaluation of the bid(s) HBCSE-TIFR, Mumbai will award the contract to the lowest evaluated responsive Bidders individual item wise. Conditional bid will be treated as unresponsive and it may be rejected.
- 8 The payment will be made on invoice basis. The invoice will be as per packing. The Contractor will prepare bill as receiving copy invoice/ challan with details of material accepted.
