The following queries were raised by the bidders or their representatives which were addressed by the HBCSE members:

1. Is it required to retain the existing housekeeping staff or entire new staff have to be provided by the contractor?

Ans. It was clarified that the same will be discussed with the contractor (winning bidder) after the award of the contract. The Contractor should be prepared/ capable of providing the full staff required as per the tender.

2. Is the submission of the EMD mandatory by all bidders?

Ans. The firms registered under MSMEs only are exempted from submission of EMD.

3. The Bank Solvency Certificate is not available in the format mentioned in the tender document. Can the Bank Solvency Certificate be submitted in the bank's format?

**Ans.** It was clarified that the bidder may submit the latest bank solvency in any format provided by the bank subject to a minimum 40% of the Contract value.

4. Will the contractor be responsible for arranging the housekeeping and maintenance materials or will it be provided by the Centre?

Ans. The materials for Housekeeping and maintenance services will be provided by HBCSE.
