The following were the queries raised by the bidders or their representatives which were addressed by the HBCSE members:

1) The Leave salary is not provided by the Central Government, but the clause regarding the leave salary is mentioned in the document. Kindly clarify how the leave salary is to be paid.

Answer: A corrigendum for the non-issuance of leave salary will be published.

2) Can bidders having Registered Offices in some other state and functional/ branch offices in Mumbai participate in the bid?

Answer: Yes, the bidder can participate in the bid process.

Will be the charges for Uniform be provided for the Fresh set in the next year as well if the contract is extended for the further period?

Answer: An amount of Rs. 2,500/- per head per year for two sets of uniforms shall be reimbursed to the contractor.

4) The clarification was sought regarding the manpower requirement that 22 will be required for 26 days, however, the services are to be rendered for the entire month. Considering that the personnel will not be allowed to work in double shift, then the total strength will increase.

Answer: It was clarified that the service of the Lady Guard will be required only for the General shift for 6 days. The services are 24/7. Hence, 1/6th of 21 (22-1 Lady Guard) approximately 3- 4 persons can be appointed for relievers duty.

Is it compulsory for the contractor to have their own Training centres or can they avail the services from other training centres?

Answer: No, the proof of the agreement between the contractor and Training Centres should be provided. (Proof ie. Agreement, MoU and contract)

Does the bidder need to have DGR empanelment or just the minimum rates of DGR to be followed?

Answer: The bidder should comply with the provision of minimum wage rate. There is no need for the DGR empanelment certificate.

- 7) It was clarified that for establishing the proof of CAR policy/ All Risk policy/ Employee liability insurance, the bidders may produce relevant documentary evidence from any other existing organization.
- 8) The Successful bidder is required to commence the contract from October 1st, 2024. It was also emphasized that it is essential to maintain proper decorum within the HBCSE premises.
- No further queries were raised by the bidder representatives. The meeting concluded at 12.00 pm and all the bidders' representatives went for the Site visit.
